

**INFORMATION PURSUANT TO ART. 13 OF LEGISLATIVE DECREE NO. 196/2003**

Dear Sir / Madam, We wish to inform you that the Legislative Decree No. 196 of June 30, 2003 ("Code regarding the protection of personal data") provides for the protection of persons and other subjects regarding the processing of personal data. According to the indicated legislation, such processing will be based on the principles of correctness, lawfulness and transparency and the protection of your privacy and your rights. Pursuant to Article 13 of Legislative Decree No. 196/2003, therefore, we provide you with the following information:

1. The data you provide (including those of your minor child) will be processed for the following purposes:

- to provide and manage the Organizational Services rendered by CCK SRL;
- to comply with applicable laws and regulations.

2. The processing will be carried out in the following ways:

data will be recorded, updated, organized and stored in computer and/or paper files suitably protected by security measures. The data will be processed and stored for a period of time not exceeding that necessary for the purposes for which it was collected. Personal information will be used only for reasons inerential to the services rendered by CCK SRL;

3. The provision of data is obligatory and refusal, due to the nature of the service rendered, will result in the non-execution of the contract and the non- continuation of the relationship;

4. Data may be disclosed to individuals involved in the company organization (administrative, marketing, commercial, legal, system administrators) or to external parties, such as third-party technical service providers, postal couriers, hosting providers, IT companies, communication agencies;

6. At any time you may exercise your rights with regard to the data controller, pursuant to Article 7 of Legislative Decree No. 196/2003.

## DISCHARGE OF LIABILITY (to be signed on each page)

By signing this deed, the undersigned for himself and/or for the minor child (as identified and over whom he declares, also on behalf of the other spouse exercising equal right, to exercise parental authority, enclosing identification document), making the following declarations and commitments his own for the same, on his behalf and with all the following

### DECLARE

1. for himself/herself and/or the minor, that he/she wishes to participate in the Event called "CHAMPION CUP KART," a recreational amateur go-kart rental event;
2. to the effect, that he or she or his or her child wishes to use, on the days of September 18, 19, 20 and 21, 2024 on the Karting track called "LIGNANO INTERNATIONAL CIRCUIT", located in Via Valle Hirschel, 2, 33050 Precenico UD, without exclusivity and in competition with other users participating in the aforementioned event, of the organizational services rendered by the company CCK SRL with its registered office in Via Ponza 2 - 10121 TORINO and that it intends to carry out the recreational sports activity, as proposed by CCK SRL, complying with all indications and regulations adhering received from CCK SRL, including through the website [www.championcupkart.com](http://www.championcupkart.com) which, as of now, he /she expressly declares to know, accept and respect without reservation. Specifically, that it intends to carry out the aforesaid activity using, on a time basis, the rental go-karts placed at the disposal of CCK SRL by the kart supplier for the performance of the rental service during the event;
3. to have, he or his child, experience in driving vehicles and, in particular, in driving on the track of mechanical means such as four-stroke rental go-karts;
4. that he or she has, in advance, viewed the facilities (the Track), the places (the Track and its appurtenances) and the vehicles (the rental go-karts) made available by CCK SRL for the performance of the activity referred to in points 1) and 2) and that he or she considers them fully and perfectly suitable for the use he or she intends to make of them;
5. to be, for himself and/or for the minor, in excellent health conditions and in any case such as to be able to carry out the activity envisaged by the amateur event without incurring risks to his state of health and, in any case, to be in the psycho-physical conditions suitable and necessary for the activity of amateur karting and, in particular, not to suffer from pathologies that are an obstacle to driving or to the carrying out of amateur motor events and, for all legal and contractual purposes, expressly self-certify such conditions not to be under the influence of narcotic, psychotropic or similar substances and/or alcohol, which may alter the normal state of perception and behavior; women also declare that they are not pregnant. By contravening these prohibitions, they expressly exonerate the company CCK SRL from any responsibility regarding harmful events for themselves and/or the minor, third parties and people and/or things;
6. to be fully aware of and/or to have informed the minor of both the regulations of the "CHAMPION CUP KART" and those, however, in force within the LIGNANO INTERNATIONAL CIRCUIT karting track and, as a result, declares that he/she is obliged to respect and/or make the minor respect the aforementioned regulations as well as all further provisions that may be issued before and during the events by the company CCK SRL and/or its employees and/or collaborators;
7. to assume all responsibility, also on behalf of the minor's activity as a participant in the event, with regard to damages, pecuniary and non-pecuniary, caused to the company CCK SRL or to third parties, declaring himself to be fully aware of carrying out and/or having carried out an amateur karting activity carried out by mechanical means and, therefore, by its nature, dangerous;
8. to be aware and to have informed the minor of the risks involved in the activity of amateur karting in which he/she intends to participate, as it is carried out by mechanical means and to expressly authorize the minor to participate;
9. to exonerate the company CCK SRL from all liability for all physical and/or pecuniary and non-pecuniary damages that may be caused to the undersigned and/or the minor due to his/her own wrongdoing and/or that of third parties;
10. to undertake to pay to have the minor pay the utmost attention to what happens on the track, also in order to detect the presence of any obstacles, in order to report them to the other drivers and to the Management of the Kartodromo and in any case to CCK srl;
11. this declaration is valid for all uses of the track subsequent to registration;
12. the declarant acknowledges the validity, also as a means of proof against him/her and/or the minor, of any images taken from the video and/or photographic recordings made by CCK SRL and/or the Kartodromo, even with the existing instruments on the facility;
13. to also be aware and to have informed the minor, as to the safety measures to be observed while on the track, of the fact that, in the use of the amateur go-kart and in any case in every phase in which access will be allowed to the track or to places connected to it or adjacent to it, he/she must maintain a conduct marked by the requirements of safety and order, necessary for the regular conduct of activities;
14. to be aware and/or to have informed the minor that he/she is obliged to comply with every directive and/or provision given by the personnel in charge (CCK srl and/or Kartodromo and/or Kart Supplier personnel) and in particular with the communications made through traffic lights and flags, as illustrated and explained in the regulation and by the personnel in charge (CCK srl and/or Kartodromo and/or Kart Supplier personnel);
15. to be aware and / or to have given information to the minor that, in case of failure to comply with even one of the above warnings, or in case of driving considered improper or dangerous to people or things, the staff in charge (CCK srl and / or Kartodromo and / or Kart Supplier staff and / or track management) has the right, in its sole discretion and at any time, to remove the user from the track and / or facilities as a whole;

16. to be aware and/or to have given notice to the minor that, in the cases provided for in the preceding clause, the Track Management (and/or CCK SRL / Race Direction) shall also have the right to ban from individual events or from the entire event the user who is the author of behavior in violation of these regulations;

17. to be aware and/or to have given notice to the minor that, in case of limitation, suspension or interruption of services, or removal for the above reasons, there will be no right to any reimbursement for the period of time or services not yet used;

18. that I am aware and/or have given notice to the minor that:

- It is forbidden to get on the go-kart with unsuitable clothing and hair, if long, must be tied and gathered and placed inside the helmet.

-It is obligatory for the user to wear a full-face helmet, with the visor always lowered.

-Access to the pit and paddock area "Technical Area" is allowed only to track personnel and drivers with permission from the track management (and/or CCK srl).

-The user, while using the go-kart, must not keep with him/her any objects that may interfere with driving or disperse on the track during the race, unless expressly authorized by the Track Management or CCK srl (see for example on board cameras)

-Users must wait for their event as per the event schedule and must strictly adhere to the directives given by the track officials (CCK srl and/or Kartodromo and/or Kart Supplier personnel and/or Track Management), especially with regard to getting on/off the go-kart.

- While using the go-karts, it is strictly forbidden to have an incorrect and dangerous driving conduct; it is also forbidden to stop along the track, get off the go-kart even in case of breakdown (you must always wait for the intervention of the staff and report the problem by raising your arm), move the go-kart by pushing it or being towed by other users; in general, adopt prejudicial, dangerous and imprudent behaviors.

19. To acknowledge and/or have given notice to the minor that the company CCK SRL, for the sole purpose of protecting the smooth and orderly conduct of the activity, reserves the right to deny access to the track, or selectively prevent access to the track to those who, as a result of their behavior are deemed unfit to participate in the event.

20. To take note and / or to have informed the minor that the company CCK SRL may at any time and at its sole discretion, proceed to the modification / integration of everything reported in the regulations of the event and also of this document, with the only obligation to provide appropriate communication to the undersigned, including by e-mail and / or Social and / or by requesting the signing of a new supplementary or replacement document.

21. That I have read and understood the information pursuant to art. 13 of Legislative Decree 196/2003, also on behalf of the minor, and that I give consent for myself and/or for the minor to CCK SRL, to the processing of personal data, including television filming and/or photographic representations made by CCK SRL or authorized third parties in the kart track, by any means and without time limits, in accordance with what is set forth in the information itself, for the purpose of the fulfillment of this agreement.

22. To be in possession of accident insurance cover for the Event for motor sport activities as per \_\_\_\_\_

All that is herein read, understood and considered, the undersigned

#### UNDERTAKES

(a) to behave (himself or the minor to whom he or she has parental authority) at all times in a manner appropriate to the circumstances and marked by respect for persons and things, as well as to scrupulously abide by the directives and instructions given by CCK SRL, of which he or she has been given full knowledge and which he or she declares to accept in full, including by signing below;

(b) to indemnify and hold harmless the company CCK SRL as well as employees or collaborators in any capacity of the same (including the Kartodromo and/or Kart Supplier staff and/or track management), from any and all damage caused to persons (whether other track users, third party spectators, track staff or others) or things (mechanical means, track facilities and safety facilities, clothing etc.), however arising from his own behavior or from the behavior of his minor child of whom he has parental authority, and in particular in the face of failure to comply with the specific rules and / or directives provided by CCK and the rules of use of the track, committing as of now to compensation for any and all damage caused to the company CCK SRL and / or third parties (including the Kartodromo and / or Kart Supplier staff and / or the track management) by himself or his minor child;

(c) to also release the company CCK SRL from any liability, obligation or compensation or payment of indemnity towards itself and/or towards the minor, or towards its successors or assigns, for any and all damaging consequences, patrimonial and/or non-patrimonial (including death) derived or deriving from the amateur activity of Rental Karting carried out during the "CHAMPION CUP KART" event, as organized by CCK SRL, including through the use of facilities (kart track) and vehicles (kart fleet), not owned by CCK SRL.

(d) to the effect that he/she expressly waives his/her right to claim against CCK SRL for any damages caused to him/her (or to the minor, in the case of a minor participating in the event) as a result of the conduct of other persons and/or participants in the event in question.

(e) by mutual agreement with the company CCK SRL, to recognize as exclusively competent, for any and all disputes originating in or otherwise relating to these regulations, the Court of TURIN
