**DOC. 1****INFORMATION PURSUANT TO ART. 13 OF LEGISLATIVE DECREE NO. 196/2003**

The Legislative Decree No. 196 of June 30, 2003 ("Code regarding the protection of personal data") provides for the protection of persons and other subjects regarding the processing of personal data. According to the indicated legislation, such processing will be based on the principles of correctness, lawfulness and transparency and the protection of privacy and rights. By signing this document, the undersigned parents, declaring to exercise parental authority over their minor \_\_\_\_\_ (SURNAME AND NAME OF THE MINOR), attaching a copy of their identity document and that of the minor, make their own, on their behalf, all the following declarations and commitments. In particular, they

**DECLARE**

1. that the minor wishes to participate in the Event called "CHAMPION CUP KART," a recreational amateur go-kart rental event; the CCK will take place from 18-21 September 2024 (Wednesday 18th - Thursday 19th: Training Sessions; Friday 20th - Saturday 21st: Championship) at the LIGNANO INTERNATIONAL CIRCUIT, located in Via Valle Hierschel, 2, 33050 Precenicco, UD;
2. for this reason, accepting the event format, to authorise the minor to take part in the recreational-sporting activity, as proposed by CCK SRL, the Organizer Company (with registered Office in Via Ponza 2 - 10121 TORINO; VAT number 12901110010) complying to all indications and regulations received from CCK SRL, also through the website [www.championcupkart.com](http://www.championcupkart.com) which they and their minor expressly know, accept and respect without reservation. For this reason to authorise their minor to use the organisational services rendered by CCK SRL during the CCK; to expressly know that CCK services will be give without exclusivity of Track or karts and with other users participating in the above mentioned Event, also over the age of 18.
3. to authorise the minor to carry out the aforementioned activity using the rental go-karts (400 cc 4-stroke karts) made available to CCK SRL by the Kart Supplier for hire during the Event;
4. that the minor has experience in driving vehicles and, in particular, in driving on the track of mechanical means such as fourstroke rental go-karts;
5. in advance, to have viewed the facilities (the Track), the places (the Track and its appurtenances) and the vehicles (the rental go-karts) made available by CCK SRL for the performance of the activity referred to in points 1) 2) and 3) and that they consider them fully and perfectly suitable for the use minor intends to make of them;
6. that the minor is in excellent health conditions and in any case such as to be able to carry out the activity envisaged by the amateur event without incurring risks to his/her state of health and, in any case, to be in the psycho-physical conditions suitable and necessary for the activity of amateur karting and, in particular, not to suffer from pathologies that are an obstacle to driving or to the carrying out of amateur motor events and, for all legal and contractual purposes; expressly self-certify that the minor is not under the influence of narcotic, psychotropic or similar substances and/or alcohol, which may alter the normal state of perception and behavior of the minor; By contravening these prohibitions, they expressly exempt the company CCK SRL from any liability for harmful events occurring to the minor, to third parties and to property, as a result of the child's conduct;
7. to have informed the minor of the regulations of the 'CHAMPION CUP KART' and of those, in any case, in force within the LIGNANO INTERNATIONAL CIRCUIT kart track and, consequently, to have the minor comply with the aforementioned regulations as well as with all further provisions that may be issued before and during the events by the company CCK SRL and/or its employees and/or collaborators;
8. to assume all responsibility, in the name and on behalf of the minor's activity as a participant in the event, with regard to damages, both pecuniary and non-pecuniary, caused to the company CCK SRL or to third parties, declaring himself to be fully aware having the minor carry out an amateur karting activity with mechanical means and, therefore, by its nature, dangerous ;
9. to be aware and to have informed the minor of the risks involved in the activity of amateur karting in which the minor intends to participate, as it is carried out by mechanical means and to expressly authorize the minor to participate;
10. to exonerate CCK SRL from all liability for any physical damage and/or pecuniary and non-pecuniary damage that may be caused to the minor through his/her own fault and/or that of third parties;
11. to undertake to pay to have the minor pay the utmost attention to what happens on the track, also in order to detect the presence of any obstacles, in order to report them to the other drivers and to the Management of the Kartodromo and in any case to CCK srl;
12. to recognise the validity, also as a means of proof against the minor, of any images taken from the video and/or photographic recordings made by CCK SRL and/or the Kartodromo, also with the instruments existing on the facility;
13. to also be aware and to have informed the minor, as to the safety measures to be observed while on the track, of the fact that, in the use of the amateur go-kart and in any case in every phase in which access will be allowed to the track or to places connected to it or adjacent to it, the minor must maintain a conduct marked by the requirements of safety and order, necessary for the regular conduct of activities;
14. to be aware and to have given notice to the minor that he/she is obliged to respect every directive and/or provision given by the personnel in charge (CCK srl and/or personnel of the Kartodromo and/or personnel of the Kart Supplier) and in particular the communications made through traffic lights and flags, as illustrated and explained in the CCK regulations and by the personnel in charge (CCK srl and/or personnel of the Kartodromo and/or personnel of the Kart Supplier);
15. to be aware and to have given notice to the minor that, in the event of failure to comply with even one of the above warnings, or in the event of driving considered incorrect or dangerous for persons or things, the personnel in charge (CCK srl and/or Kartodromo and/or Kart Supplier's personnel and/or track management) has the right, at its sole discretion and at any time, to remove the user from the track and/or the facilities as a whole;
16. to have given notice to the minor that, in the cases provided for in the previous clause, the Track Management (and/or CCK SRL/Competition Management) will also have the right to ban from individual events or from the entire event any user who engages in behaviour in breach of these regulations;
17. to be aware and to have given notice to the minor that, in the event of limitation, suspension or interruption of services, or of removal for the above-mentioned reasons, there shall be no entitlement to a refund for the period of time or services not yet used;

18. to be aware and to have given notice to the minor that: - It is forbidden to get on the go-kart with unsuitable clothing and the hair, if long, must be tied and collected and placed inside the helmet; -it is compulsory to wear a full-face helmet, with the visor always lowered; -access to the pit and paddock area 'Technical Area' is allowed only to the track staff and drivers with the authorisation of the track management (and/or CCK srl). -during the use of the go-kart, the minor must not take with him/her any objects that may interfere with driving or scatter on the track during the race, unless expressly authorised by the Race Direction or by CCK srl (see for example on-board video cameras) -the minor must wait for his/her event as per the programme and must scrupulously follow the instructions given by the track officials (CCK srl and/or Kartodromo and/or Kart Supplier's staff and/or Race Direction), in particular as regards getting on/off the go-kart. - During the use of the go-karts it is strictly forbidden to have an incorrect and dangerous driving behaviour; it is also forbidden to stop along the track, to get off the go-kart also in case of breakdown (it is always necessary to wait for the intervention of the personnel and to signal the problem by raising the arm), to move the go-kart pushing it or being towed by other users; a female pregnant driver is not allowed to race; in general, to adopt prejudicial, dangerous and imprudent behaviours.

19. to be aware and to have given notice to the minor that CCK SRL, for the sole purpose of protecting the regular and orderly carrying out of the activity, reserves the right to deny access to the Track, or to selectively prevent access to the Track to those who due to their behavior are deemed unfit to participate in the Event.

20. to be aware and to have given notice to the minor that CCK SRL may at any time and at its sole discretion, proceed with the modification/integration of everything reported in the Event regulations and also of this document, with the sole obligation to give appropriate communication to the undersigned , also via email and/or social media and/or requesting the signing of a new supplementary or replacement document.

21. to have read and understood the information pursuant to art. 13 of Legislative Decree 196/2003, also on behalf of the minor, giving consent to CCK SRL to the processing of personal data, including television filming and/or photographic representations made by CCK SRL or authorized third parties in the kart track, by any means and without time limits, in accordance with what is set forth in the information itself, for the purpose of the fulfillment of this agreement.

22. that the minor is in possession of the CNS LIBERTAS card n. \_\_\_\_\_ (space to be filled in by the Organizer on the Track; card without cost for the driver), already issued by CCK with the registration of the minor at the event for his/her insurance coverage against any accidents during the event;

23. that this declaration is valid for all uses of the Track subsequent to registration, official free practice included (18 and 19 september 2024).

#### UNDERTAKE

(a) that the minor always behave in a manner appropriate to the circumstances and characterized by respect for people and things, as well as scrupulously comply with the directives and instructions given by CCK SRL, of which they have had full knowledge and which they declare to accept, for the minor, in full, also with their signature below;

(b) to indemnify and hold harmless the company CCK SRL as well as employees or collaborators in any capacity of the same (including the Kartodromo and/or Kart Supplier staff and/or track management), from any and all damage caused to persons ( whether other track users, third party spectators, track staff or others) or things (mechanical means, track facilities and safety facilities, clothing etc.), however arising from the behavior of their minor of whom they have parental authority, and in particular in the face of failure to comply with the specific rules and/or directives provided by CCK and the rules of use of the track, committing as of now to compensation for any and all damage caused to the company CCK SRL and / or third parties (including the Kartodromo and / or Kart Supplier staff and / or the track management) by the minor;
